A Local Law Amending the Current Zoning Map of the Village of Pittsford

NOW, therefore be it enacted, that the Village of Pittsford Board of Trustees hereby:

Adopts the First Amendment to the November 21, 2019 Zoning Map of the Village of Pittsford, a copy of which First Amendment is annexed hereto as Exhibit A.

Amend the Table of Minimum Parking Space Requirements set forth in Section 210-25.2 C of the Code of the Village of Pittsford to read:

Restaurant, Tavern or Brewpub (see note (1)) 1 per 4 seats plus 1 per employee of max shift

**A Local Law Amending Section 195-32 and Section 195-33 of the
Zoning Code of the Village of Pittsford**

NOW, therefore be it enacted, that the Village of Pittsford Board of Trustees hereby:

Amend Section 195-32 of the Code of the Village of Pittsford to add to Schedule VI:

Name of Street	Side	Hour/Days	Location
Monroe Avenue	South	4:00 PM – 6:30 AM/M-F	From a point 55 feet west of South Main Street to a point 265 feet west of South Main Street

Amend Section 195-33 of the Code of the Village of Pittsford to eliminate the following from Schedule VIII:

Name of Street	Side	Hour/Days	Location
Monroe Avenue	South	30 mins.; except no parking 4:00 PM – 6:00 PM/M-F	From a point 55 feet west of South Main Street to a point 265 feet west of South Main Street
