**A Local Law to amend Chapter 210, Zoning, of the Village Code of the Village of Pittsford,
Eliminating the R-5 District and Rezoning the Land in the R-5 District to MU-EC**

Be it hereby enacted by the Board of Trustees of the Village of Pittsford as follows:

SECTION I.

A Section 210-20.1, Districts established, is hereby amended to delete the line
“Residential R-5.”

B. Section 210-20.3(C), Residential, is hereby deleted and § 210-20.3(D) is re-numbered
as § 210-20.3(C).

C. Chapter 210 attachment I and addendum, Article VA, R-5 Residential District, is
hereby deleted.

SECTION II. REZONING TO MU-EC

- A. The official map of the Village is hereby amended to zone those areas as shown on
the current zoning map as R-5 to MU-EC.
- B. Nothing in this local law shall affect the validity of any currently existing uses in the
R-5 District which shall be legal non-conforming uses in accordance with Article 17
of Chapter 210 of the Village Code. For purposes of this Section only, any project
being built in phases shall be considered a legally existing use if any phase is under
construction as of the effective date of this Local Law. For purposes of this Section
only, any project that has received Final Site Plan approval as of the effective date of
this Local Law shall be considered a legally existing use.

SECTION III. VALIDITY

The invalidity of a word, section, clause, paragraph, sentence, or part of provision of this local
law shall not affect the validity of any other part of this local law that can be given effect without
such invalid part or parts.

SECTION III. EFFECTIVE DATE

This law shall take effect immediately, as provided by the law, upon filing with the Secretary of
State
